CERTIFICATE OF WATER RIGHT

This is to Certify, That MARGARET A. GEARNIART

of Van, State of Oregon has a right to the use of

the waters of Wolf Creek and Spring for Tract #1; Calanity Creek for Tract #2; Wolf and Calanity Creeks for Tract #4; for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8, at page 228; that the priority of the right thereby confirmed dates from June 8, 1883 for Tracts #1 and #2; May 15, 1887 for Tract #4;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre in any 30-day period prior to June 1st, 1 acre foot per acre in any 30-day period after June 1st, of each year, or 3 acre feet per acre during any season, diverted at a rate not to exceed one-twentieth of a cubic foot per second per acre;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1: 18 acres in the SW 1/4 NW 1/4, 14 acres in the NW 1/4 SW 1/4, 1 acre in the NW 1/4 SW 1/4, 5 acres in the SE 1/4 SW 1/4, 14 acres in the SW 1/4 SE 1/4, Section 29, 5 acres in the SE 1/4 NE 1/4, Section 30, 13 acres in the NW 1/4 NE 1/4, Section 32, T. 18 S. R. 33 1/2 E. W. M., being a total of 70 acres.

Tract #2: 33.5 acres in the NW 1/4 SW 1/4, Section 29, 26 acres in the NE 1/4 SE 1/4, 6.7 acres in the SE 1/4 NE 1/4, Section 30, T. 18 S. R. 33 1/2 E. W. M., being a total of 71.2 acres.

Tract #3: 23 acres in the NW 1/4 SW 1/4, 4 acres in the SW 1/4 SW 1/4, Section 29, 10 acres in the NE 1/4 SE 1/4, Section 30, T. 18 S. R. 33 1/2 E. W. M., being a total of 37 acres.

Tract #4: 2 acres in the SW 1/4 NW 1/4, 7 acres in the NE 1/4 SW 1/4, 10 acres in the NW 1/4 SW 1/4, 6 acres in the SW 1/4 SW 1/4, 35 acres in the SE 1/4 SW 1/4 and 1 acre in the SW 1/4 SE 1/4, Section 29, 25 acres in the NW 1/4 NE 1/4, 34 acres in the NE 1/4 NW 1/4 and 2 acres in the NW 1/4 NW 1/4, Section 32, T. 18 S. R. 33 1/2 E. W. M., being a total of 122 acres.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
