CERTIFICATE OF WATER RIGHT

This is to Certify, That

JASON S. HUNTER

of Beulah

has a right to the use of

the waters of East Fork Ben Deere Creek for Tracts #1 and #2; Little Crane Creek for Tract #5; for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8, at page 228; that the priority of the right thereby confirmed dates from 1883 for Tract #1; 1884 for Tract #2; 1890 for Tract #3;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1½ acre feet per acre in any 30-day period prior to June 1st, 1 acre foot per acre in any 30-day period after June 1st, of each year, or 5 acre feet per acre furing any season, diverted at a rate not to exceed one-twentieth of a cubic foot per second per acre;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

- Tract #1: 10 acros in NW\family 21 acros in SV\family, 7 acros in NW\family 21 acros in SV\family 30\family 30\family 50\family 50\famil
- Tract #2: 5 acres in NW, SE, 9 acres in SW, SE, Section 1; 14 acres in NE, NE, 1 acres in NW, NE, 15 acres in SE, 25 acres in NE, SE, 18 acres in NW, SE, 9 acres in SW, 29 acres in SE, 25 acres in NE, 25 acres in NE, NE, 15 acres in SE, 29 acres in SE, Section 12, 25 acres in NE, 15 acres in SE, Section 13, T. 18

 S. R. 37 E. W. M., being a total of 177 acres.
- Tract #5: 5 acres in SE NW, 8.5 acres in NE SW, 3 acres in SW, SW, Section 22, 17.5 acres in NV NW, 15.5 acres in SW, NW, 10.5 acres in NV SW, Section 27, 8 acres in SE NE, Section 28, T. 24 S. R. 35 E. V. M., being a total of 66 acres.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
