CERTIFICATE OF WATER RIGHT (HB - 2153)

confirms the right to store the waters of
NORTH SANTIAM RIVER, A TRIBUTARY OF SANTIAM RIVER IN SEVEN
RESERVOIRS, TO BE APPROPRIATED UNDER APPLICATION 75318
for FOREST MANAGEMENT.

The right to store and use these waters was perfected under Reservoir Application R-75317.
The date of priority is January 1, 1993. The amount of water entitled to be stored and
used each year under this right is not more than 1.08 ACRE-FEET, BEING
0.16 AF IN TOM ROCK CABIN, 0.26 AF IN N ROCK CREEK, 0.25 AF IN
DONKEY SLIDE, 0.1 AF IN WAGON ROAD, 0.12 AF IN BURBANK BLOWDOWN,
0.09 AF IN BURBANK 2 AND 0.1 AF IN GREEN MOUNTAIN



NE 1/4 SE 1/4 SECTION 12, TOWNSHIP 10 SOUTH, RANGE 3 EAST WM.
SE 1/4 SW 1/4 SECTION 5, TOWNSHIP 10 SOUTH, RANGE 4 EAST WM.
SW 1/4 SW 1/4 SECTION 4, TOWNSHIP 10 SOUTH, RANGE 4 EAST WM.
EN 1/4 W 1/4 SECTION 32, TOWNSHIP 9 SOUTH, RANGE 4 EAST WM.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, with
a minimum diameter of 8", or the provision of other means to evacuate water when determined necessary
for public safety or to satisfy prior downstream rights as determined by the Water Resources Director.

The right to store and use the water for the above purpose is restricted to beneficial use at the place of
use listed above.
