CERTIFICATE OF WATER RIGHT

This is to Certify, That J. L. SITZ

of Drewsey, State of Oregon has a right to the use of
the waters of Middle Fork Malheur
for the purpose of Irrigation and the development of 20 H. P.

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
County, and the said decree entered of record at Salem, in the Order
Record of the STATE ENGINEER, in Volume 8, at page 228; that the priority
of the right thereby confirmed dates from Malheur 1892 for Tract #1; 1888 for Tract #2; 1898
for the diversion of 21.3 sec. ft. for the development of 20 H. P.

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre
in any 30-day period prior to June 1st, 1 acre foot per acre in any 30-day period
after June 1st, of each year, or 3 acre feet per acre during any season, diverted
at a rate not to exceed one-twentieth of a cubic foot per second per acre;
A description of the lands irrigated under such right, and to which the water is appurtenant
(or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1: 30 acres in NE 1/4 SW 1/4, 10 acres in SW 1/4 SW 1/4, 5 acres in SE 1/4 SW 1/4, 15 acres
in NW 1/4 SE 1/4, 2 acres in SW 1/4 SE 1/4, 20 acres in SE 1/4 SE 1/4, Section 12, T. 20 S. R. 34 E.
W. M.; 30 acres in SW 1/4 SW 1/4, 30 acres in SE 1/4 SW 1/4, Section 7, 25 acres in NE 1/4 NW 1/4,
20 acres in SE 1/4 NW 1/4, 15 acres in NW 1/4 SE 1/4, Section 18, T. 20 S. R. 35 E. W. M.,
being a total of 202 acres. (Note: Now irrigated from Drewsey Reclamation Co.
ditch.)

Tract #2: 2 acres in NE 1/4 SW 1/4, 6 acres in SW 1/4 SW 1/4, 30 acres in SE 1/4 SW 1/4, 37 acres
in SW 1/4 SE 1/4, 18 acres in SE 1/4 SE 1/4, Section 12, 17 acres in NE 1/4 NE 1/4, 18 acres in NW 1/4 NE 1/4,
Section 13, T. 20 S. R. 34 E. W. M. 8 acres in SW 1/4 SW 1/4, 6 acres in SE 1/4 SW 1/4, Section
7, 15 acres in NE 1/4 NW 1/4, 40 acres in NW 1/4 NW 1/4, 15 acres in SW 1/4 NW 1/4, 16 acres in SE 1/4 NW 1/4,
8.5 acres in NE 1/4 SW 1/4, 13 acres in NW 1/4 SE 1/4, Section 18, T. 20 S. R. 35 E. W. M.,
being a total of 251.5 acres.

And said right shall be subject to all other conditions and limitations
contained in said decree.
The right to the use of the water for irrigation purposes is restricted to the lands or place
of use herein described.
