CERTIFICATE OF WATER RIGHT

This is to Certify, That WESTERN FARM & CATTLE COMPANY, Successors  
 of Ontario, State of Oregon in interest to J. A. Williams has a right to the use of  
 the waters of Middle Fork Malheur for Tracts #1 and #2; Calamity Creek for Tract  
 #3;  
 for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for  
 Malheur County, and the said decree entered of record at Salem, in the Order  
 Record of the STATE ENGINEER, in Volume 8, at page 22B; that the priority  
 of the right thereby confirmed dates from 1883 for Tract #1; 1889 for Tract #2; 1884  
 for Tract #3;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an  
 amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre  
 in any 30-day period prior to June 1st, 1 acre foot per acre in any 30-day period  
 after June 1st, of each year, or 3 acre feet per acre during any season, diverted  
 at a rate not to exceed one-twentieth of a cubic foot per second per acre;

A description of the lands irrigated under such right, and to which the water is appurtenant  
 (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1: 5 acres in NE 1/4 SW 1/4, 26 acres in NE 1/4 SE 1/4, 18 acres in NW 1/4 SE 1/4, 40 acres  
 in SE 1/4 SE 1/4, 40 acres in SW 1/4 SE 1/4, Section 25, T. 19 S. R. 33 1/2 E. W. M., being a  
 total of 129 acres.

Tract #2: 15 acres in SW 1/4 NE 1/4, 36 acres in NE 1/4 NW 1/4, 35 acres in NW 1/4 NW 1/4, 6 acres  
 in SW 1/4 NW 1/4, 34 acres in SE 1/4 NW 1/4, 14 acres in NE 1/4 SW 1/4, 14 acres in NE 1/4 SE 1/4, 17 acres  
 in NW 1/4 SE 1/4, Section 25, 23 acres in SW 1/4 SW 1/4, 10 acres in SE 1/4 SW 1/4, Section 24, T. 19  
 S. R. 33 1/2 E. W. M., being a total of 205 acres.

Tract #3: 10 acres in SE 1/4 SE 1/4, Section 23, 14 acres in NE 1/4 NE 1/4, Section 26,  
 11 acres in SW 1/4 SW 1/4, Section 24, 5 acres in NW 1/4 NW 1/4, Section 25, T. 19 S. R. 33 1/2  
 E. W. M., being a total of 40 acres.

And said right shall be subject to all other conditions and limitations  
 contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place  
 of use herein described.
