used each year under this right is not more than 1.0 ACRE-FEET, BEING
0.1 AF RES 11, 0.1 AF IN RES 12, 0.1 AF IN RES 13, 0.1 AF IN RES 14,
0.1 AF IN RES 15, 0.1 AF IN RES 16, 0.1 AF IN RES 17, 0.1 AF IN RES
18, 0.1 AF IN RES 19, AND 0.1 AF IN RES 20



The right to store and use the water for the above purpose is restricted to beneficial use at the place of use listed above.
