CERTIFICATE OF WATER RIGHT

This is to Certify, That GEO. & ROY WELLS

of Korby, State of Oregon has a right to the use of
 the waters of Sucker Creek
 for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Josephine County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volumes 1 & 5, at pages 253 & 399; that the priority of the right thereby confirmed dates from 1873 for Tract #1; 1908 for Tract #2;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.1 cubic feet per second for Tract #1; 0.79 cubic foot per second for Tract #2; and that the use of water for irrigation purposes shall be confined to the season April 1st to October 31st of each year;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1: 10 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, 40 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 19, 25 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 20, 17 $\frac{1}{2}$ acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 29, 30 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, 20 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ and 12 $\frac{1}{2}$ acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 30, T. 39 S. R. 7 W. W. M., being a total of 155 acres.

Tract #2: 4.3 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 19, 9.25 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, 11.55 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, 14.55 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, 16.34 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 30, 0.75 acre in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, 6.37 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 29, T. 39 S. R. 7 W. W. M., being a total of 63.11 acres.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
