confirms the right to store the waters of  
NINE RESERVOIRS AND STORE WATERS OF UNNAMED STREAMS, TRIBUTARIES OF  
PARSNIP CREEK  
for LIVESTOCK.

The right to store and use these waters was perfected under Reservoir Application R-80311.  
The date of priority is January 1, 1993. The amount of water entitled to be stored and  
used each year under this right is not more than 2.72 ACRE-FEET, BEING  
0.45 AF IN RESERVOIR 1, 0.67 AF IN RESERVOIR 2, 0.11 AF IN RESERVOIR  
3, 0.15 AF IN RESERVOIR 4, 0.2 AF IN RESERVOIR 5, 0.15 AF IN  
RESERVOIR 6, 0.14 IN RESERVOIR 7, 0.19 IN RESERVOIR 8 AND 0.66 AF IN  
RES 9

The right to store and use the water for the above purpose is restricted to beneficial use at the place of  
use listed above.
