CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JEDEDIAH AYLETT
ROUTE 1, BOX 1818
HERMISTON, OREGON 97838

confirms the right to use the waters of A WELL in the UMATILLA RIVER BASIN for IRRIGATING 14.6 ACRES.

This right was perfected under Permit G-190. The date of priority is MARCH 26, 1956. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.183 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The quantity of water appropriated at the new well together with that appropriated from the old well shall not exceed the quantity of water available at the original well under the subject right.

The well is located as follows:

SW 1/4 SW 1/4, SECTION 19, T 4 N, R 27 E, W.M.; 1077 FEET NORTH AND 910 FEET EAST FROM THE SW CORNER OF SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4 10.1 ACRES
NW 1/4 SW 1/4 4.5 ACRES
SECTION 19
TOWNSHIP 4 NORTH, RANGE 27 EAST, W.M.

The new well must be maintained so as not to penetrate the underlying basalts.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This certificate is issued to confirm a change in POINT OF APPROPRIATION AND PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 27, 1989, and together with Certificate 60553, supersedes Certificate 49077, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
