CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of FALL CREEK, a tributary of MIDDLE FORK WILLAMETTE RIVER, for IRRIGATING 7.9 ACRES, TEMPERATURE CONTROL ON 9.8 ACRES, AND CONTAINERIZED NURSERY USE ON 1.9 ACRES.

This right was perfected under Permit 50735. The date of priority is MAY 25, 1989. This right is limited to 0.41 CUBIC FOOT PER SECOND, BEING 0.10 CFS FOR IRRIGATION, 0.12 CFS FOR TEMPERATURE CONTROL AND 0.29 CFS FOR CONTAINERIZED NURSERY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NE 1/4, SECTION 4, T 19 S, R 1 W, W.M.; 1399 FEET SOUTH AND 919 FEET WEST FROM THE NE CORNER OF SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The use of water allowed under this certification shall conform to such reasonable rotation system as may be ordered by the proper state officer.

If used for field irrigation for nursery stock, such use is not restricted to the defined agricultural irrigation season.

The water user shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control on forms furnished.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
