CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Edward W. Coles Haines, OR, 97833

confirms the right to use the waters of Rock Creek, Sand Creek, and Powder River, a tributaries of Snake River for irrigation of 549.8 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon and BAKER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291, Powder River Decree. The dates of priority are July, 1880 for 100.00 acres and 1890 for 153.4 acres in Tract 1; 1900 for 86 acres in Tract 2; 1880 for 127 acres in Tract 3; April 28, 1881 for 13.0 acres in Tract 4 and 1906 for 52 acres in Tract 5.

The amount of water entitled and hereby confirmed for the purposes aforesaid is limited to an amount actually beneficially used and shall not exceed **ONE FORTIETH** of one cubic foot per second per acre **or** its equivalent in case of rotation.

The point of diversion is described and located as follows:
