CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BONNEVILLE POWER ADMINISTRATION AND ARMY CORPS OF ENGINEERS, WALLA WALLA DISTRICT BUILDING 602, CITY-COUNTY AIRPORT WALLA WALLA, WASHINGTON 99362

confirms the right to use the waters of FOUR WELLS in the COLUMBIA RIVER BASIN for FISH CULTURE.

This right was perfected under Permit G-11210. The date of priority is AUGUST 20, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 9.11 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the wells.

The wells are located as follows:

WELL 1 - SW 1/4 NW 1/4, SECTION 15, T 5 N, R 26 E, W.M.; 100 FEET NORTH AND 117 FEET EAST FROM THE W 1/4 CORNER OF SECTION 15.

WELL 2 - NW 1/4 SW 1/4, SECTION 15, T 5 N, R 26 E, W.M.; 600 FEET SOUTH AND ON SECTION LINE FROM THE W 1/4 CORNER OF SECTION 15.

WELL 3 - NW 1/4 SW 1/4, SECTION 15, T 5 N, R 26 E, W.M.; 1195 FEET SOUTH AND ON SECTION LINE FROM THE W 1/4 OF SECTION 15.

WELL 4 - SE 1/4 SE 1/4, SECTION 16, T 5 N, R 26 E, W.M.; 1785 FEET SOUTH AND 10 FEET WEST FROM THE W 1/4 CORNER OF SECTION 15.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4 SECTION 15 TOWNSHIP 5 NORTH, RANGE 26 EAST, W.M.

The Director may require water level or pump test results every ten years.

The use of water shall be limited when it interferes with the prior SURFACE OR GROUNDWATER rights of others.

When required by the Department, the user shall install and maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.
