CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DICKMAN FARMS  
15829 MT. ANGEL - SCOTTS MILLS HWY NE  
SILVERTON, OREGON 97381

confirms the right to use the waters of TWO WELLS in the ZOLLNER CREEK BASIN for IRRIGATING 116.2 ACRES.

This right was perfected under Permits G-8794 AND G-6392. The dates of priority are JULY 20, 1979 - FOR 0.38 CUBIC FOOT PER SECOND; AND MARCH 17, 1975 - FOR 0.67 CFS. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.05 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion from the wells. The quantity of water diverted at the new point of appropriation (well) shall not exceed the quantity of water available at the original point of appropriation.

The wells are located as follows:

WELL 3 - NW 1/4 SW 1/4, SECTION 18, T 6 S, R 1 E, W.M.; 1330 FEET NORTH AND 1270 FEET EAST FROM THE SW CORNER OF SECTION 18.

WELL 5 - SE 1/4 SW 1/4, SECTION 18, T 6 S, R 1 E, W.M.; 530 FEET NORTH AND 1370 FEET EAST FROM THE SW CORNER OF SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

THE PURPOSE OF THIS RIGHT IS TO ALLOW ALL OF SAID LANDS TO BE IRRIGATED FROM THE ORIGINAL WELL (WELL 3) AND ALSO FROM AN ADDITIONAL WELL (WELL 5).

Water shall be acquired from the same aquifer as the original point of appropriation.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm AN ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered JANUARY 8, 1991, and supersedes Certificate 52668 AND 52669, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
