CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DON DODSON, LOUISE DODSON, AND ZELDA JOY HARROD
51407 OREGON HIGHWAY 237
NORTH POWDER, OREGON 97867

confirms the right to use the waters of WOLF CREEK, a tributary of POWDER RIVER, for IRRIGATION OF 272.5 ACRES.

This right was perfected under Permit 2173. The date of priority is OCTOBER 14, 1911. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.41 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

WOLF CREEK - SW 1/4 NW 1/4, SECTION 16, T 6 S, R 39 E, W.M.; 2311 FEET SOUTH AND 407 FEET EAST FROM THE NW CORNER OF SECTION 16; WOLF CREEK DAM - SW 1/4 SE 1/4, SECTION 11, T 6 S, R 38 E, W.M.; 570 FEET NORTH AND 1550 FEET WEST FROM THE SE CORNER OF SECTION 11.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent in cast of rotation.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new point of diversion, together with the diverted at the original SUNNYSLOPE AND KELSEY-MOORE DITCH AT WOLF CREEK, shall not exceed the quantity of water available at the original point of diversion.

THE QUANTITY OF WATER DIVERTED FROM WOLF CREEK SHALL BE NO MORE THAN 95% OF THE WATER THAT WAS HISTORICALLY USED FROM THE NORTH POWDER RIVER UNDER THE FORMER PRIMARY RIGHT.


When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm changes in POINT OF DIVERSION AND USE FROM SUPPLEMENTAL IRRIGATION TO PRIMARY IRRIGATION, approved by an order of the Water Resources Director entered OCTOBER 18, 1990, and together with Certificate 64972, supersedes Certificate 4926, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
