CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LA PINE COOPERATIVE WATER ASSOCIATION

LA PINE, OREGON 97739

confirms the right to use the waters of the LITTLE DESCHUTES RIVER, a tributary of the DESCHUTES RIVER, for IRRIGATING 1471.05 acres.

This right was confirmed by decrees of the Circuit Court of the State of Oregon for DESCHUTES County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 16, at Page 185. The date of priority is 1897 for 759.3 acres, 1900 for 70.0 acres, and APRIL 30, 1902 for 641.75 acres.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) FROM MAY 23 TO AUGUST 20, AND ONE-EIGHTIETH of one cubic foot per second (or its equivalent) FROM APRIL 1 TO MAY 23 AND FROM AUGUST 20 TO NOVEMBER 1, and 4.0 acre-feet for each acre irrigated, measured at the point of diversion from the source, during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The point of diversion is located as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$ SECTION 34, TOWNSHIP 23 SOUTH, RANGE 9 EAST, W.M.;
550 FEET NORTH AND 1150 FEET EAST FROM THE SW CORNER OF SECTION 34.
