 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GERALD LOENNIG

confirms the right to use the waters of NORTH POWDER RIVER, tributary of POWDER RIVER for DOMESTIC, STOCK and IRRIGATION of 120.7 acres.

This right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County. The said decree is of record at Salem, in the Order record of the WATER RESOURCES DIRECTOR, Volume 3, Page 252. The priority dates of the right hereby confirmed are 1862 for domestic and stock, 1870 for 87 acres of irrigation, 1884 for stock and irrigation of 33.7 acres.

The amount of water entitled and hereby confirmed for this right, for the purposes aforesaid, is limited to an amount actually beneficially used for the said purposes, and shall not exceed 3.02 cubic feet per second from March 1st to July 1st, and shall not exceed 1.51 cubic feet per second from July 1st to October 1st, or its equivalent in case of rotation. This right is further limited to a total diversion not to exceed 2½ acre feet for each acre irrigated during the irrigation season of each year.

The points of diversion from the source are located:

- POD # 1 Hutchinson Hillside Ditch - being within the NW¼ NE¼, Section 5, Township 7 South, Range 38 East, W.M.; 140 feet South and 2380 feet West from the NE corner of Section 5, Township 7 South, Range 38 East, W.M.
- POD # 2 Powers Ditch - being within the SW¼ SE¼, Section 32, Township 6 South, Range 38 East, W.M.; 1030 feet North and 1660 feet West from the NE corner of Section 32, Township 6 South, Range 38 East, W.M.


* Priorities marked with an asterisk have a stock water right under priority 1862 in the corresponding quarter quarters.

This certificate describes that portion of the water rights confirmed by Certificates 1468 and 51836, State Record of Water Right Certificates, modified by the provisions of an order of the Director entered on APR 15 1996, 1996, and recorded in Special Order Volume 50, Page 204, approving a petition by Gerald Loennig under ORS 541.329.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
