CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of NORTH POWDER RIVER, a tributary of POWDER RIVER for DOMESTIC, STOCK and IRRIGATION of 4.0 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER and UNION Counties. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7, at Page 441. The date of priority is 1884.

The amount of water entitled and hereby confirmed for the purposes aforesaid is limited to 0.10 CUBIC FOOT PER SECOND from March 1 to July 1 and 0.05 CUBIC FOOT PER SECOND from July 1 to October 1 or its equivalent in case of rotation, and is further limited to a total diversion not to exceed 2½ acre feet for each acre irrigated or 10.0 acre-feet during the irrigation season of each year, measured at the point of diversion from the source.

The point of diversion is located as follows:

Powers Ditch - being within the SW¼ SE¼, Sec. 32, T. 6 S., R. 38 E., W.M.; 1030 feet North and 1660 feet West from the NE corner, Sec. 32, T. 6 S., R. 38 E., WM.

A description of the place of use to which this right is appurtenant is as follows:

SW¼ NE¼ 4.0 acres
Section 32
Township 6 South, Range 38 East, W.M.


This certificate describes that portion of the water right confirmed by Certificate 51836, issued in the name of Armand W. Perkins, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Director entered on APR 15 1996, 1996, and recorded in Special Order Volume 50, Page 204, approving a petition by Gerald Loennig under ORS 541.329.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
