confirms the right to use the waters of A WELL in the MURDOCK CREEK BASIN for IRRIGATING 502.5 ACRES.

This right was perfected under Permit G-7242. The date of priority is FEBRUARY 4, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 5.12 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source. The quantity of water appropriated at the new well shall not exceed the quantity of water available at the old well under the subject right.

The well is located as follows:

LOT 1 (NW 1/4 NW 1/4), SECTION 30, T 28 S, R 15 E, W.M.; AT THE NW 1/4 CORNER OF SECTION 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate is issued to confirm a change in POINT OF APPROPRIATION AND PLACE OF USE approved by an order of the Water Resources Director entered JULY 13, 1988, and to correctly describe lands being irrigated. This Certificate supersedes Certificates 52563 and 52215, State Record of Water Right Certificates and Transfer Order T-5488.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
