CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORTH UNIT IRRIGATION DISTRICT 2024 NW BEACH STREET MADRAS, OREGON 97741

confirms the right to use the waters of DESCHUTES RIVER, WICKIUP RESERVOIR constructed under Permit R-1677, and HAYSTACK RESERVOIR constructed under Permit R-1754, tributaries of the COLUMBIA RIVER, for IRRIGATION of 133.9 ACRES.

This right was perfected under Permit 23196. The date of priority is February 28, 1913. The amount of water to which this right is entitled is limited to an amount of water actually beneficially used and shall not exceed 3.35 CUBIC FOOT PER SECOND, or its equivalent in case of rotation. The amount of water to which this right is entitled is further limited to the combined total amount of water for all other rights perfected under Permit 23196 which shall not exceed 1,101.0 CUBIC FOOT PER SECOND. The amount of water will be measured at the points of diversion from the sources.

The points of diversion are located as follows:

Deschutes River - SE ¼ NE ¼, SECTION 29, TOWNSHIP 17 SOUTH, RANGE 12 EAST, W.M.; 1,700 FEET SOUTH AND 730 FEET WEST FROM THE NE CORNER OF SECTION 29.

Wickiup Reservoir - SW ¼ NE ¼, SECTION 7, TOWNSHIP 22 SOUTH, RANGE 9 EAST, W.M.

Haystack Reservoir - SW ¼ NE ¼, SECTION 27, TOWNSHIP 12 SOUTH, RANGE 13 EAST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 5 ½ acre-feet per acre for each acre irrigated during the irrigation season of each year, and is further subject to the terms and conditions of the State Engineer's Orders dated January 20, 1955 and February 4, 1955.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
