CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORTH UNIT IRRIGATION DISTRICT
2024 NW BEACH STREET
MADRAS, OREGON 97741

confirms the right to use the waters of CROOKED RIVER, a tributary of the DESCHUTES RIVER, for IRRIGATION of 8,525.80 ACRES and 5.0 ACRES EQUIVALENT for INDUSTRIAL use.

This right was perfected under Permit 33954. The date of priority is September 18, 1968. The amount of water to which this right is entitled, together with all other rights perfected under Permit 33954, is limited to an amount actually beneficially used and shall not exceed 200.0 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW ¼ NE ¼, SECTION 13, TOWNSHIP 14 SOUTH, RANGE 13 EAST, W.M.;
590 FEET NORTH AND 2,790 FEET EAST FROM THE W ¼ CORNER, SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4 acre-feet for each acre irrigated during the irrigation season of each year, and is further subject to the terms and conditions of a stipulation between the North Unit Irrigation District and the Oregon State Game Commission which has been recorded in the Miscellaneous Records of the Water Resources Director.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
