CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J. F. HUTCHINSON
UNION, OREGON

confirms the right to use the waters of GRANDE RONDE RIVER, a tributary of SNAKE RIVER, for IRRIGATION.

This right was confirmed by decree of the circuit Court of the State of Oregon for UNION County. The decree is of record in Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at Page 1. The date of priority is 1864 FOR TRACT NO. 1; 1867 FOR TRACT NO. 2; 1876 FOR TRACT NO. 3.

The use is limited to 1.52 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

Tract No. 1 Red Mill Ditch, Sec. 13, T4S, R39E, WM
Tract No. 2 Dobbs Slough Ditch
Tract No. 3 Coffin Ditch, SE $\frac{1}{4}$ SW $\frac{1}{4}$, Sec. 13, T4S, R39E, WM

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 36609, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUL 30 1996, approving Transfer Application 7450.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
