CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GERALD EDWARDS 93298 RIVER ROAD JUNCTION CITY, OREGON 97448

confirms the right to use the waters of A WELL in the WILLAMETTE RIVER BASIN for IRRIGATING 13.5 ACRES.

This right was perfected under Permits G-1599 and G-560. The priority dates are MAY 23, 1960 - for 0.16 CUBIC FOOT PER SECOND AND MAY 9, 1957 - for 0.006 CFS. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.166 CFS, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

SW 1/4 NE 1/4, SECTION 9, T 16 S, R 4 W, W.M.; 2066 FEET SOUTH AND 468 FEET EAST FROM THE NORTH 1/4 CORNER OF SECTION 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SECTION 9

The quantity of water diverted at the new point of appropriation shall not exceed the quantity of water available from the original points of appropriation.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
