CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TWO WELLS in the COLUMBIA RIVER BASIN for FISH CULTURE AT IRRIGON FISH HATCHERY.

This right was perfected under Permit G-11229. The date of priority is FEBRUARY 4, 1991. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 14.04 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

WELL 1 - SE 1/4 SW 1/4, SECTION 15, T 5 N, R 26 E, W.M.; 1259 FEET NORTH AND 2263 FEET EAST FROM THE SW CORNER OF SECTION 15.

WELL 2 - NW 1/4 NE 1/4, SECTION 22, T 5 N, R 26 E, W.M.; 112 FEET SOUTH AND 3858 FEET EAST FROM THE SW CORNER OF SECTION 15.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SE 1/4 SECTION 15 TOWNSHIP 5 NORTH, RANGE 26 EAST, W.M.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

When required by the department, the user shall install and maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The Director may require water level or pump test results every ten years.

The use of water shall be limited when it interferes with any prior SURFACE OR GROUNDWATER rights of others.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
