CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of KRUMBO CREEK, a tributary of DONNER UND BLITZEN RIVER, for MAINTAINING KRUMBO RESERVOIR CONSTRUCTED UNDER PERMIT R-2124 AND KRUMBO RESERVOIR ENLARGEMENT CONSTRUCTED UNDER PERMIT R-11162 FOR PUBLIC RECREATIONAL PURPOSES INCLUDING WILDLIFE ATTRACTION, FISHING, BOATING, AND SCENIC ATTRACTION.

This right was perfected under Permit 50750. The date of priority is JANUARY 26, 1989. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 5.0 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NW 1/4, SECTION 19, T 30 S, R 32 E, W.M.; 4320 FEET NORTH AND 3294 FEET WEST FROM SE CORNER OF SECTION 19.

The water user shall comply with the terms and conditions of an order recorded in volume 43 pages 403 through 407 and stipulated agreement recorded in volume 43 pages 408 through 413, order records of the Water Resources Director.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
