CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of NORTH UMPQUA RIVER, a tributary of UMPQUA RIVER, for IRRIGATION OF 25.6 ACRES.

This right was perfected under Permit 51289. The date of priority is OCTOBER 29, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.32 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 38, SECTION 15, T 26 S, R 4 W, W.M.; 150 FEET NORTH AND 1180 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 15.

Diversion screening or fish passage facilities shall be maintained and operated to Oregon Department of Fish & Wildlife specifications.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SE 1/4 2.28 ACRES
SW 1/4 SE 1/4 9.17 ACRES
SE 1/4 SE 1/4 14.15 ACRES
ALL AS PROJECTED WITHIN DLC 38
SECTION 10
TOWNSHIP 26 SOUTH, RANGE 4 WEST, W.M.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
