CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHAMBERLAIN DITCH COMPANY c/o TOM BERNHARDT 75282 UPPER DIAMOND LANE WALLOWA, OR 97885

confirms the right to use the waters of BEAR CREEK, a tributary of WALLOWA RIVER, for DOMESTIC, STOCK AND IRRIGATION OF 1375.4 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for WALLOWA County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5, at Page 151, 152, 153, and 154. The dates of priority are 1883 for Tracts 1, 2, and 3; 1893 for Tracts 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, and 30.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.5 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season.

Chamberlain Ditch - SE% SW%, SECTION 22, TOWNSHIP 1 NORTH, RANGE 42 EAST, W.M.
