CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of THREE WELLS in the INGRAM SLOUGH BASIN for SUPPLEMENTAL IRRIGATION OF 229.3 ACRES.

This right was perfected under Permit G-11004. The date of priority is JANUARY 18, 1989. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.87 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

WELL 15 - NE 1/4 SW 1/4, SECTION 4, T 16 S, R 4 W, W.M.; NORTH 26 DEGREES 35 MINUTES 12 SECONDS WEST 1488.68 FEET FROM THE S 1/4 CORNER OF SECTION 4.

WELL 16 - SW 1/4 SE 1/4, SECTION 5, T 16 S, R 4 W, W.M.; NORTH 65 DEGREES 30 MINUTES 53 SECONDS EAST 1444.88 FEET FROM THE S 1/4 CORNER OF SECTION 5.

WELL 17 - SW 1/4 NW 1/4, SECTION 4, T 16 S, R 4 W, W.M.; NORTH 49 DEGREES 24 MINUTES 03 SECONDS EAST 1709.50 FEET FROM W 1/4 CORNER OF SECTION 4.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

When required by the department, the water user shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of groundwater withdraw.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights.

The Director may require water level or pump test results every ten years.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
