confirms the right to use the waters of THE MCKENZIE RIVER, a tributary of THE WILLAMETTE RIVER, for IRRIGATING 26.95 ACRES.

This right was perfected under Permit 46188. The date of priority is AUGUST 22, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.34 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 4 (NW 1/4 NW 1/4), SECTION 34, T 16 S, R 2 E, W.M.; 238 FEET SOUTH, AND 354 FEET EAST FROM THE NW CORNER OF SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 5 (NE 1/4 NW 1/4) 0.70 ACRE
LOT 4 (NW 1/4 NW 1/4) 21.50 ACRES
SW 1/4 NW 1/4 4.50 ACRES
LOT 6 (SE 1/4 NW 1/4) 0.25 ACRE
SECTION 34
TOWNSHIP 16 SOUTH, RANGE 2 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
