CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARTHUR THOMAS AND\OR ROSE ADAIR 1314 EAST LYNWOOD SPACE 120 SAN BERNIDINO, CA 92404

confirms the right to use the waters of AN UNNAMED SPRING, a tributary of ANDREWS CREEK, AND ANDREWS CREEK, a tributary of BILLY CREEK, for DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 1.6 ACRES.

This right was perfected under Permit 50527. The date of priority is NOVEMBER 12, 1987 - FOR 0.02 CUBIC FOOT PER SECOND FROM ANDREWS CREEK AND OF 0.0005 CFS FROM THE SPRING; AND NOVEMBER 30, 1988 - FOR 0.0025 CFS FROM THE SPRING. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.023 CFS, BEING 0.003 CFS FROM AN UNNAMED SPRING FOR DOMESTIC USE, AND 0.02 CFS FROM ANDREWS CREEK FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SPRING - NW 1/4 SE 1/4, SECTION 2, T 23 S, R 6 W, W.M.; 1090 FEET SOUTH AND 720 FEET EAST FROM THE C 1/4 CORNER OF SECTION 2.

CREEK - NE 1/4 SE 1/4, SECTION 2, T 23 S, R 6 W, W.M.; 1070 FEET SOUTH AND 2230 FEET EAST FROM THE C 1/4 CORNER OF SECTION 2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 SE 1/4 DOMESTIC
NE 1/4 SE 1/4 1.6 ACRES
SECTION 2
TOWNSHIP 23 SOUTH, RANGE 6 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
