CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARGARET LANDSEN
7661 SOUTH OSTER ROAD
WOODBURN, OREGON 97071

confirms the right to use the waters of TWO WELLS in the BUTTE CREEK BASIN for IRRIGATING 137.5 ACRES.

This right was perfected under Permit G-10294 AND G-10475. The dates of priority are NOVEMBER 15, 1983 - FOR 0.40 CUBIC FOOT PER SECOND; JANUARY 30, 1985 - FOR 0.51 CFS; AND JANUARY 31, 1985 - FOR 0.35 CFS. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.26 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

WELL 4 - SE 1/4 SE 1/4, SECTION 19, T 5 S, R 1 E, W.M.; 870 FEET NORTH AND 60 FEET WEST FROM THE SE CORNER OF SECTION 19.

WELL 5 - NW 1/4 NE 1/4, SECTION 30, T 5 S, R 1 E, W.M.; 30 FEET SOUTH AND 1460 FEET WEST FROM THE NE CORNER OF SECTION 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new points of appropriation (wells) shall not exceed the quantity of water available from the original points of appropriation.

When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original points of appropriation.

This certificate is issued to confirm a change in POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered AUGUST 12, 1991, and together with Certificate 66615, supersedes Certificate 62692 AND 65628, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
