CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KEITH CROCKER ROUTE 3 JUNCTION CITY, OREGON

confirms the right to use the waters of WELL NO. 2 and WELL NO.3, in the LONG TOM RIVER BASIN for IRRIGATION of 6.4 ACRES AND SUPPLEMENTAL IRRIGATION of 65.7 ACRES.

This right was perfected under Permit G-2591. The date of priority is JANUARY 15, 1964. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.45 CUBIC FOOT PER SECOND, BEING 0.37 CUBIC FOOT PER SECOND FROM WELL NO. 2 AND 0.08 CUBIC FOOT PER SECOND FROM WELL NO. 3 or its equivalent in case of rotation, measured at the well.

The well is located as follows:

WELL NO. 2 - NE¼ NW¼, AS PROJECTED WITHIN THE RICHARDSON DLC 44, SECTION 15, TOWNSHIP 14 S., RANGE 5 W., W.M.; 1130 FEET NORTH AND 1100 FEET WEST FROM THE SE CORNER, RICHARDSON DLC

WELL NO. 3 - SW4 SW4, AS PROJECTED WITHIN THE RICHARDSON DLC 44, SECTION 10, TOWNSHIP 14 S., RANGE 5 W., W.M.; 2420 FEET NORTH AND 2260 FEET WEST FROM THE SE CORNER, RICHARDSON DLC

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent, for each acre irrigated and shall be further limited to a diversion of not to exceed 2% acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
