CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EDWARD N. & DIANE C. ALMOJUELA

confirms the right to use the waters of ONE WELL in the GOOSE LAKE BASIN for IRRIGATION AND SUPPLEMENTAL IRRIGATION OF 49.80 ACRES.

This right was perfected under Permit G-11169. The date of priority is OCTOBER 30, 1989. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.6 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source. THE USE ALLOWED HEREIN MAY BE MADE ANYTIME BETWEEN APRIL 1 TO NOVEMBER 15 OF EACH YEAR THAT WATER CAN BE PUT TO BENEFICIAL USE BY IRRIGATION FOR IMMEDIATE PLANT GROWTH.

The well is located as follows:

NE 1/4 NE 1/4, SECTION 13, T 39 S, R 19 E, W.M.; SOUTH 33 DEGREES 17 MINUTES 37 SECONDS WEST A DISTANCE OF 586 FEET FROM THE NE CORNER OF SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated.

The use of water shall be further limited to a diversion of not to exceed 3.0 ACRE-FEET per acre for each acre irrigated during the period APRIL 1 TO SEPTEMBER 30 of each year, and shall be further limited to a diversion of not to exceed 0.75 ACRE-FOOT for each acre irrigated during an extension of the irrigation season, being the period from OCTOBER 1 TO NOVEMBER 15 of each year. Provided further that the right allowed herein shall not exceed 3.0 ACRE-FEET for each acre irrigated in any one year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

When required by the department, the user shall install and maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
