CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RAYMOND K. AND RUTH LAMARCHE 1009 WEST 6TH THE DALLES, OREGON 97058

confirms the right to use the waters of THE DESCHUTES RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 0.34 ACRE.

This right was perfected under Permit 3438. The date of priority is JULY 19, 1917. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.004 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water available at the original point of diversion.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 31, T 16 S, R 12 E, W.M.; 835 FEET SOUTH AND 1298 FEET WEST FROM THE NE CORNER OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 NE 1/4 0.21 ACRE NW 1/4 NE 1/4 0.13 ACRE SECTION 31 TOWNSHIP 16 SOUTH, RANGE 12 EAST, W.M.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 25, 1992, and together with Certificates 67306, 67307, 67308, 67309, 67310, 67311, 67313, 67315, 65135, and 68533, supersedes Certificate 29926, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
