## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DICKMAN FARMS, INC. 15829 MT. ANGEL-SCOTTS MILLS HWY NE SILVERTON, OREGON 97381

confirms the right to use the waters of TWO WELLS in the BUTTE CREEK BASIN for SUPPLEMENTAL IRRIGATION OF 32.7 ACRES.

This right was perfected under Permit G-10144. The date of priority is SEPTEMBER 20, 1983. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.21 CUBIC FOOT PER SECOND FROM TWO WELLS, or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

WELL NO. 1 - NW 1/4 NW 1/4, SECTION 17, T 6 S, R 1 E, W.M.; 1200 FEET SOUTH AND 80 FEET EAST FROM THE NW CORNER OF SECTION 17.

WELL NO. 2 - SE 1/4 NW 1/4, SECTION 17, T 6 S, R 1 E, W.M.; 1470 FEET SOUTH AND 1990 FEET EAST FROM THE NW CORNER OF SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NW 1/4 0.1 ACRE
SW 1/4 NW 1/4 27.4 ACRES
SE 1/4 NW 1/4 0.2 ACRE
NW 1/4 SW 1/4 5.0 ACRES
ALL AS PROJECTED WITHIN DLC 41
SECTION 8
TOWNSHIP 6 SOUTH, RANGE 1 EAST, W.M.

When required by the Department, the water user shall install and maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The type and plans of the headgates and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 7, 1991, and together with Certificate 65144, supersedes Certificate 62398, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
