CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LLOYD DUYCK
ROUTE 2, BOX 485
CORNELIUS, OREGON 97113

confirms the right to use the waters of the Well No. 3, a tributary of the Tualatin River, for the irrigation of 94.0 acres and supplemental irrigation of 201.9 acres.

This right was perfected under Permit G-4751. The date of priority is November 20, 1969. The use is limited to 2.31 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, as projected within Emerick DLC 46, Section 5, Township 1 South, Range 3 West, WM; 1560 feet South and 1700 feet East from the NW Corner, Emerick DLC 46.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
