CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD E. CADDOCK 1606 WILDRIVER DRIVE ROSEBURG, OREGON 97470

confirms the right to use the waters of NORTH UMPQUA RIVER, a tributary of THE UMPQUA RIVER, for IRRIGATING 21.9 ACRES.

This right was perfected under Permit 50798. The date of priority is JULY 31, 1989. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.27 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SW 1/4, AS PROJECTED WITHIN DLC 40, SECTION 14, T 26 S, R 4 W, W.M.; 2170 FEET NORTH AND 3160 FEET WEST FROM THE SE CORNER OF SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4 11.0 ACRES
SE 1/4 SW 1/4 3.4 ACRES
NW 1/4 SE 1/4 1.0 ACRE
SW 1/4 SE 1/4 6.5 ACRES
ALL AS PROJECTED WITHIN DLC 40
SECTION 14
TOWNSHIP 26 SOUTH, RANGE 4 WEST, W.M.

Diversion screening or fish passage facilities shall be maintained and operated to Oregon Department of Fish & Wildlife specifications.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
