## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIS E. CAMPBELL 8865 DAYS CREEK CUTOFF ROAD CANYONVILLE, OR 97417

confirms the right to use the waters of SOUTH UMPQUA RIVER, a tributary of UMPQUA RIVER, for IRRIGATION OF 41.0 ACRES.

This right was perfected under Permit 51491. The date of priority is OCTOBER 14, 1987. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.51 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 42, SECTION 8, T 30 S, R 4 W, W.M.; 1100 FEET NORTH AND 160 FEET EAST FROM THE SW CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4 17.2 ACRES NW 1/4 SW 1/4 10.0 ACRES BOTH AS PROJECTED WITHIN DLC 39

NE 1/4 SE 1/4 1.8 ACRES
NW 1/4 SE 1/4 12.0 ACRES
BOTH AS PROJECTED WITHIN DLC 44
SECTION 8
TOWNSHIP 30 SOUTH, RANGE 4 WEST, W.M.

Water shall not be appropriated from direct flow during the period July 15 through September 30 of each year except for irrigation of not to exceed one-half acre non-commercial garden.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
