CERTIFICATE OF WATER RIGHT

This is to Certify, That LUCINDA J. SOUTH

of Baker, State of Oregon has a right to the use of the waters of Durbin Creek for Tract #1; Burnt River for Tract #2; for the purpose of Irrigation;

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8, at page 134; that the priority of the right thereby confirmed dates from 1864 for Tract #1; 1866 for Tract #2;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Three acre feet per acre during any irrigation season, nor a rate of one-fortieth of a cubic foot per second per acre;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1: 2 acres in the SW<sup>1</sup>/<sub>4</sub>SE<sup>1</sup>/<sub>4</sub>, Section 12, T. 14 S. R. 44 E. W. M.

Tract #2: 9 acres in the SE<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub>, 15 acres in the NE<sup>1</sup>/<sub>4</sub>SE<sup>1</sup>/<sub>4</sub>, 5 acres in the SE<sup>1</sup>/<sub>4</sub>SE<sup>1</sup>/<sub>4</sub>, Section 11, 10 acres in the NW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub>, 23 acres in the SW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub>, 4 acres in the SE<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub>, Section 12, T. 14 S. R. 44 E. W. M.

(NOTE: 15 acres in SW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub> and 8 acres in SE<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub> also irrigated from Durbin Creek under date of 1864.)

(This certificate is issued to supersede that certain certificate issued to Huntington Meat Company, Ja. 21, 1926, and recorded in State Record of Water Right Certificates, Volume 6, page 5938, the right for 5 acres of land under said certificate having been transferred to Oregon Portland Cement Company by order of the State Engineer dated July 2, 1927, under the provisions of Chap. 219, Laws of Oregon for 1927.)

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
