CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of THE ROGUE RIVER, a tributary of THE PACIFIC OCEAN, for IRRIGATING 68.2 ACRES.

This right was perfected under Permit 298. The date of priority is JULY 26, 1909. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.358 CUBIC FOOT PER SECOND, BEING 0.345 CFS FOR WILSON TRACT AND 0.013 FOR WORTHYLAKE TRACT, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 4 (NW 1/4 SE 1/4), SECTION 17, T 35 S, R 1 W, W.M.; 960 FEET SOUTH AND 3370 FEET EAST FROM THE W 1/4 CORNER OF SECTION 17.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
