## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

Kerns Bros Inc. Rural Route 1 Haines, OR 97833

confirms the right to use the waters of Rock Creek, Pine Creek and Willow Creek, tributaries of Powder River, for the irrigation of 39.10 acres.

This right was confirmed by Powder River decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6 at Page 291. The date of priority is December 4, 1899.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.62 CUBIC FOOT PER SECOND or its equivalent in case of rotation.

The points of diversion are located as follows:

Wilcox Ditch from Willow Creek - SE¼ NW¼, Section 3, T. 7 S., R. 38 E., W.M.; 2370'S. and 2410'E. from NW Corner, Sec. 3, T. 7 S., R. 38 E., W.M.

Williams Ditch from Pine Creek - NW¼ NW¼, Section 26, T. 8 S., R. 38 E., W.M.; 220'S. and 1000'W. from NW Corner of Sec. 26, T. 8 S., R. 38 E., W.M.

Welch Ditch from Pine Creek - NE¼ NW¼, Section 26, T. 8 S., R. 38 E., W.M.; 1010'S. and 2200'W. from NW Corner of Sec. 26, T. 8 S., R. 38 E., W.M.

Wilcox Ditch from Rock Creek - NW¼ SE¼, Section 33, T. 7 S., R. 38 E., W.M.; 1580'N. and 1430'W. from SE Corner, Sec. 33, T. 7 S., R. 38 E., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:
