## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of a well, a tributary of the Powder River Basin for supplemental irrigation for 227.60 acres.

This right was perfected under Permit G-7630. The date of priority is June 9, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.84 CUBIC FEET PER SECOND or its equivalent in case of rotation.

The well is located as follows:

NW¼ SE¼, Section 21, T 8 S, R 39 E, WM; 1840 feet North and 1370 feet West from SE corner, Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
