confirms the right to use the waters of Pine creek, a tributary of Powder River, for irrigation of 314.54 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The Powder River decree is of record in Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The dates of priority are 1904 for 79.09 acres; 1909 for 79.09 acres; and April 1863 for 156.36 acres.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 7.86 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

Cartmill Ditch (L.B. and O.P. Ison Ditch) - SE¼ NW¼, Section 25, T. 8 S., R. 38 E., W.M.; 2650'S. and 1960'W. from NW Corner of Sec. 25, T. 8 S., R. 38 E., W.M. For 1904 and 1909 priorities.

Boles Ditch - NW¼ SE¼, Section 29, T. 8 S., R. 39 E., W.M.; 2170'N. and 2600'W. from SE Corner, Sec. 29, T. 8 S., R. 39 E., W.M. For April 1863 priority.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:
