# CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

Wilcox Ditch Company c/o Brad Allen Rural Route 1 Haines, OR 97833

confirms the right to use the waters of Rock Creek, Pine Creek, Willow Creek, and Kilmerque Creek, tributaries of Powder River, for the irrigation of 2163.1 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The Powder River decree is of record in Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The date of priority is Dec. 4, 1899.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 34.18 CUBIC FEET PER SECOND or its equivalent in case of rotation.

The points of diversion are located as follows:

Wilcox Ditch from Rock Creek - NW¼ SE¼, Section 33, Township 7 South, Range 38 East, WM; 1580 feet North and 1430 feet West from SE corner, Section 33.

Wilcox Ditch from Willow Creek - SE¼ NW¼, Section 3, Township 8 South, Range 38 East, WM; 2370 feet South and 2410 feet East from NW corner, Section 3.

Dry Gulch Ditch from Pine Creek - SE¼ NE¼, Section 26, T 8 S, R 38 E, WM

## Kilmerque Creek

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.
