CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DEPARTMENT OF MICROBIOLOGY OREGON STATE UNIVERSITY P.O. BOX 1086 CORVALLIS, OREGON 97331

confirms the right to use the waters of TWO WELLS in the WILLAMETTE RIVER BASIN for FISH DISEASE LABORATORY TO INCLUDE RESEARCH INVOLVING REARING AND TESTING FISH, CLEANING TANKS AND FACILITY, AS WELL AS SANITARY FACILITIES FOR PERSONNEL.

This right was perfected under Permit G-10936. The date of priority is MAY 30, 1989. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.89 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

WELL NO. 1 - NW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 67, SECTION 36, T 11 S, R 5 W, W.M.; 441 FEET NORTH AND 698 FEET WEST FROM THE NW CORNER OF DLC 69.

WELL NO. 2 - NW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 67, SECTION 36, T 11 S, R 5 W, W.M.; 505 FEET NORTH AND 701 FEET WEST FROM THE NW CORNER OF DLC 69.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NE 1/4 AS PROJECTED WITHIN DLC 67 SECTION 36 TOWNSHIP 11 SOUTH, RANGE 5 WEST, W.M.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

When required by the Department, the water user shall install and maintain a meter, weir, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

This right is for the beneficial use without waste. By law, the land use associated with this water must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights.
