CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT ZIMMERMAN 6978 NORTH APPLEGATE ROAD MURPHY, OREGON 97533

confirms the right to use the waters of APPLEGATE LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-7810, for IRRIGATION OF 0.7 ACRES.

This right was perfected under Permit 50759. The date of priority is NOVEMBER 22, 1988. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.15 ACRE-FEET OF STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

RESERVOIR - S 1/2 SE 1/4, SECTION 25, T 40 S, R 4 W, W.M..

RIVER (1) - SE 1/4 NW 1/4, SECTION 21, T 37 S, R 5 W, W.M.; 1550 FEET SOUTH & 2200 FEET EAST FROM NW CORNER OF SECTION 21 (JOSEPHINE COUNTY).

RIVER (2) - SW 1/4 SW 1/4, SECTION 6, T 38 S, R 4 W, W.M.; 950 FEET NORTH & 200 FEET EAST FROM THE SW CORNER OF SECTION 6 (JACKSON COUNTY).

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of NOT TO EXCEED 4.5 ACRE-FEET for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NW 1/4 0.7 ACRE SECTION 20 TOWNSHIP 37 SOUTH, RANGE 5 WEST, W.M.

The use of water under this right is subject to the terms and conditions of Contract No. 9-07-10-W0733 between the Bureau of Reclamation and the water user, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.

This right is for the beneficial use of water without waste.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
