CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SOUTH UMPQUA RIVER, a tributary of UMPQUA RIVER, for DOMESTIC USE FOR ONE FAMILY INCLUDING IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NON-COMMERCIAL GARDEN.

This right was perfected under Permit 51399. The date of priority is MAY 29, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.01 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source. IT IS FURTHER PROVIDED THAT THE RIGHT ALLOWED HEREIN SHALL BE LIMITED DURING THE PERIOD OF JULY 1 THROUGH OCTOBER 31 OF EACH YEAR TO HUMAN CONSUMPTION, LIVESTOCK CONSUMPTION FOR SUCH ANIMALS AS ARE ESSENTIAL TO THE PROPER SUSTENANCE OF THE FAMILY AND IRRIGATION OF A NON-COMMERCIAL GARDEN NOT TO EXCEED 1/2 ACRE IN AREA.

The point of diversion is located as follows:

SW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 37, SECTION 29, T 30 S, R 3 W, W.M.; 830 FEET NORTH AND 2390 FEET WEST FROM E 1/4 CORNER OF SECTION 29.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NE 1/4
SECTION 29
TOWNSHIP 30 SOUTH, RANGE 3 WEST, W.M.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
