CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORMAN A. REILING 10773 FELLER ROAD NE HUBBARD, OREGON 97032

confirms the right to use the waters of THREE WELLS in the MILL CREEK BASIN for IRRIGATION OF 92.0 ACRES.

This right was perfected under Permit G-11123. The date of priority is MAY 15, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.15 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

WELL NO. 1 - SW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 93, SECTION 24, T 5 S, R 2 W, W.M.; 2297 FEET SOUTH AND 1320 FEET WEST FROM THE NE CORNER OF SECTION 24.

WELL NO. 2 - SW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 88, SECTION 24, T 5 S, R 2 W, W.M.; 360 FEET NORTH AND 540 FEET WEST FROM THE NE CORNER OF DLC 93.

WELL NO. 3 - NE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 88, SECTION 24, T 5 S, R 2 W, W.M.; 710 FEET NORTH AND 1750 FEET EAST FROM THE SW CORNER DLC 88 OF SECTION 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

In the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

When required by the department, the user shall install and maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The Director may require water level or pump test results every ten years.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
