CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RUSSELL R. AND BERNICE A. KULM
ROUTE 2, WESTFIELD ADDITION NO. 2
PENDLETON, OREGON 97801

confirms the right to use the waters of A WELL in the MCKAY CREEK BASIN for IRRIGATION OF 95.7 ACRES.

This right was perfected under Permit G-8483. The date of priority is FEBRUARY 1, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.92 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

SE 1/4 SW 1/4, SECTION 17, T 2 N, R 32 E, W.M.; 90 FEET NORTH AND 120 FEET WEST FROM THE S 1/4 CORNER OF SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SECTION 20

TOWNSHIP 2 NORTH, RANGE 32 EAST, W.M.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered APRIL 30, 1990, and together with Certificate 64232, supersedes Certificate 53553, State Record of Water Right Certificates.
