CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WIGRICH FARM, INC. (BY:ROBERT J. FITTS)

INDEPENDENCE, OREGON 97351

confirms the right to use the waters of the WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 125.4 ACRES.

This right was perfected under Permit 33775. The date of priority is JULY 24, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.57 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 7 (SW $\frac{1}{4}$  SE $\frac{1}{4}$ ), SECTION 34, T 8 S, R 4 W, W.M.; 2560 FEET NORTH AND 950 FEET WEST FROM THE NW CORNER, JOHNSON DLC 41.

LOT 1 (NE $\frac{1}{4}$  NW $\frac{1}{4}$ ), SECTION 2, T 9 S, R 4 W, W.M.; 1830 FEET NORTH AND 3390 FEET EAST FROM THE NW CORNER, JOHNSON DLC 41.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 39184, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered SEP 20 1996, approving Transfer Application 6857.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
