CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CROOKED RIVER CENTRAL DITCH COMPANY RURAL ROUTE 1, BOX 109 REDMOND, OREGON 97756

confirms the right to use the waters of THE CROOKED RIVER, a tributary of THE DESCHUTES RIVER, for IRRIGATING 20.9 ACRES AND SUPPLEMENTAL IRRIGATION OF 35.7 ACRES.

This right was perfected under Permit 4260. The date of priority is OCTOBER 3, 1919. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.71 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

- #1- PEOPLES IRRIGATION COMPANY CANAL NW¼ SW¼, SECTION 8, T 15 S, R 16 E, W.M.; 730 FEET SOUTH AND 330 FEET EAST FROM THE WEST ¼ CORNER OF SECTION 8.
- #2 CROOKED RIVER CENTRAL DITCH COMPANY CANAL NW¼ NE¼, SECTION 27, T 14 S, R 15 E, W.M.; 80 FEET SOUTH AND 1240 FEET EAST FROM THE NORTH ¼ CORNER OF SECTION 27.
- #3 DIRECT DIVERSION #43 NE $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 19, T 14 S, R 15 E, W.M.; 1050 FEET SOUTH AND 30 FEET WEST FROM THE NE CORNER OF SECTION 19.
- #4 DIRECT DIVERSION #45 SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 19, T 14 S, R 15 E, W.M.; 970 FEET NORTH AND 1730 FEET EAST FROM THE WEST $\frac{1}{4}$ CORNER OF SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
